OPERATION CORPORATEITEM 1. INTELLIGENCE

1. SIR HENRY LEACH (Representing the Chief of the Defence Staff) invited the Director of Service Intelligence to update them on current intelligence.
2. AIR VICE-MARSHAL ARMITAGE (Director of Service Intelligence) reviewed the latest summary (1). He said it appeared that 4 EXOCET missiles might already be en route from France to Argentina, but that the British Ambassador in Paris had been instructed by the Foreign and Commonwealth Office to attempt to have this shipment stopped. More EXOCET missiles could be sent from France through Spain in about 10 days time, and there was also evidence that Argentina was seeking the supply of EXOCET missiles from Brazil, South Africa, Libya and Iraq.
3. In subsequent discussion the point was made that it appeared that if the Argentine army and naval forces ashore in the Falkland Islands pooled their existing food stocks there could be sufficient rations, including compo, to sustain them until 23 May without re-supply.

4. The Task Force organisation was set out in the Force Tote Sitrep (2).

ITEM 3. PUBLIC RELATIONS

5. MR McDONALD (Deputy Chief of Public Relations) reported on press coverage. He said that, in accordance with their instructions (3), he had met the editors of those embarked correspondents who had earlier expressed dissatisfaction (4) with the arrangements for the release of their material. He would prepare a signal for the Secretary of State's and their approval later that day, informing the Task Force Commander of the outcome of this meeting.

6. In discussion it was agreed that, for the present, no change should be made to the arrangements which had already been promulgated whereby mail for personnel involved in Operation CORPORATE should be addressed via BFPO 666.

7. Summing up a short discussion, SIR HENRY LEACH said they would wish to invite the Vice Chief of the Defence Staff (Personnel and Logistics) urgently to examine and report to them the arrangements for handling the mail of personnel involved in Operation CORPORATE.

ITEM 5. RULES OF ENGAGEMENT

9. The Committee were informed that the Rules of Engagement for surface ships against Argentine commercial aircraft conducting surveillance (7) had yet to be promulgated.

10. Summing up a short discussion, SIR HENRY LEACH said they would wish to instruct the Assistant Chief of the Defence Staff (Operations), in conjunction with the Defence Secretariat, to prepare a submission to be forwarded to the Secretary of State immediately after their meeting.

ITEM 6. DEFENCE OF ASCENSION ISLAND

11. SIR HENRY LEACH said they had before them a draft submission (8) to the Secretary of State prepared by the Air Force Department.
